The Board of Education of the Unalaska City School District met in the high school library in Unalaska on Thursday, March 21, 2002. Board President, Tammy Fowler-Pound, called the meeting to order at 7:00 PM. Guests were introduced.

The Board took the following actions:

- ❖ Approved 2002-2003 Teaching Contracts.
- ❖ Approved the ½% for Art recommendations presented by Chairperson Jerah Chadwick of the ½% for Art Committee.
- ❖ Heard a curriculum update from Darrell Sanborn for Science, Social Studies, Vocational Education, and Aleut Language and Culture.
- ❖ Approved the request for the loan of The Volcano Woman piece of artwork by John Hoover to the Anchorage Museum through September, 2002. Anne Rowland, Curator of the Museum of the Aleutians, will supervise the shipping of the piece to Anchorage.
- ❖ Heard a report from the Elementary School Festivities Committee. The committee has a suggestion form that will be distributed throughout the community, and the suggested names are due back to the committee by April 30.

- ❖ Approved a resolution that will be forwarded to the legislature that asks the legislature to develop a Fiscal Plan for FY 03.
- ❖ Approved the February 28, 2002 financials as presented.
